- * (Note 4) A copy of certificate of medical examination for seafarers (only for applicants of College of Maritime Science)

A) An applicant should take a medical checkup (including a special health examination) with all the checkup items, and the checkup report should include a declaration by a certified doctor.

B) The examination should be carried out in a medical institution which is higher than the level of hospital or which is registered in regional Maritime Affairs and Fisheries Offices.

V. Admission Process

- 1. The admission decision is based 100% on the interview test.
- 2. Process
 - A. Applicants are chosen based on the overall assessment of personality, suitability to majors, possibility of development, etc.
- B. Applicants not attending the interview test are disqualified.
- C. Standard for successful applicants
 - 1) The applicant with the score of 60 or higher passes the interview.
 - 2) Those not detailed in this guide will follow the decision of the KMOU admission committee.


VI. Interview

VII. Online Application

1. Procedure



[Guidance on Collection and Use of Personal Information]

O The KMOU collects and utilizes the following personal information for the admission procedure.

- Personal Information: name, foreign registration number, address, telephone number, mobile phone number, e-mail address, school report, etc.
- Academic Information: the highest level in academic background, name of enrolled universities, (prospective) graduation year, Telephone/FAX number of universities, etc.
- Others: additional contact point, etc.
- O The personal information of applicants will not be used for other purposes except for entrance, scholarship, academic affairs and statistics. In the case that the information is considered unnecessary because of the expired storage period or the accomplished purpose of data, the information will immediately be destroyed.
- O The personal information of (admitted) applicants will be used for the following purposes: academic affairs, employment, academic information, engineering accreditation, university membership, webmail user information, web disk user information and text messaging service.

VIII. Notes for Applicants

- 1. Disadvantages (such as cancellation of admission) due to insufficient submission documents, errors in writing applications, errors in writing contacts and addresses (contact immediately during screening), unconfirmation of successful candidates, loss of contact, etc. are the responsibility of the applicant.
- 2. If the application documents are found to have been passed by fraudulent means, such as forgery or alteration, the admission will be canceled and academic records canceled.
- 3. All application documents are not returned except for the graduation certificate that cannot be reissued in your country.
- 4. An applicant cannot to cancel change the applying department after receiving an application (after payment)
- 5. An applicant can apply to only one unit of our university
- 6. An applicant must bring their identification card (foreign registration card, passport, etc.) and with them for the interview.
- 7. Successful applicants must be aware of the notice "Precautions for Successful Applicants" on our university website and pay tuition fees according to the details thereof, and if they do not register within the designated period, the admission will be cancelled.
- 8. If you want to refund tuition fees, you must waive registration on our university admission information website and process the application through the refund application site.
- 9. Matters that are not specified in the this guideline are subject to the decision of our university's Admission Management Committee.
- 10. Successful applicants must subscribe to domestic medical insurance (National Health Insurance, etc.) and submit certificates of insurance coverage.
- 11. Changes in schools between the same degree courses in Korea may have limitation considering the total length of sojourn in Korea, so the relevant applicant must inquire in advance before application.
- 12. This guideline is written in Korean and English, and in case of interpretation differences, we strictly follow the guideline that is written in Korean.
- 13. If an applicant registers(pays tuition fee) to two or more universities at the same time, his admission and registration will be cancelled.
- 14. If the visa application is rejected by the Koeran Embassy or the Immigration Office, the admission shall be cancelled, and tuition fees shall be refunded.

Visual Acuity		Applicants for the Division of Maritime Transportation Science, Division of Navigation Science, Department of Coast Guard Studies, and Division of Global Maritime Studies should have the corrected vision of 0.5 or higher for each eye. Applicants for the Division of Marine System Engineering, Division of Marine Engineering, Department of Offshore Plant Management, and Division of Marine Information Technology should have the corrected vision of 0.4 or higher. Applicants take the test from five meters away from the tes chart.
Physica	l Fitness	Applicants who have weak and frail body and are considered physically unfit for the performance on a ship cannot be accepted.
Dis	eases	Applicants must not be under any infectious diseases provided in the Article 2-1 of the Infectious Disease Control and Prevention Act, mental disorder provided in the Mental Health Act, and the diseases of lungs, pleura, heart or kidneys.
Hearing		Applicants for the Division of Maritime Transportation Science, Division of Navigation Science, Department of Coast Guard Studies, and Division of Global Maritime Studies should be able to hear a whisper from five meters or more away for two ears. Applicants for the Division of Marine System Engineering, Division of Marine Engineering, Department of Offshore Plant Management, and the Division of Marine Information Technology should be able to hear a whisper from five meters or more away for at least one ear. In spite of the preceding provision, anyone who has proper career as a seafarer can be accepted.
